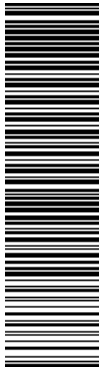

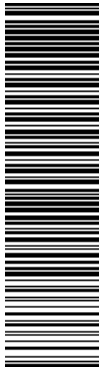

### Pakistan tourist visa checklist

- Filled out and signed Pakistan tourist visa application form.** The form is enclosed.
- Original Passport.** Passport must have at least 6 months remaining validity and have at least 1 visa page.
- 2 Photographs.** Standard passport photographs 2x2 inches on a white background.
- Payment.** Credit Card Authorization form, Certified Check, or Money Order payable to **VisaHQ.ie**.
- Return mailer.** Prepaid self-addressed return label or payment for FedEx.
- Proof of residence.** Proof of residency in Ireland is required. Please submit as many documents as possible from the following list:
  - Copy of Irish Visa
  - Copy of tenancy agreement
  - Water bill
  - Copy of the full Irish drivers license - Original GNIB Card.
- Itinerary.** Copy of round trip **tickets or confirmed itinerary.**
- Bank Statement.** Copies of original bank statements from the past 3 months (no online statements accepted).

**Employment Letter.** An original letter from your employer/school (on business letterhead, with contact details), stating that a leave of absence has been granted and that you will be returning to your current job. The Employment Letter must be addressed to Pakistan High Commission. If you are self-employed, include a copy of your business license and tax return. If you are retired please submit proof of your retirement fund.

**Sponsor Letter.** A letter from their sponsor or tour operator company in Pakistan. The tour operator must also provide tour operator's registration with the Government of Pakistan.

If you wish to prepay return shipping, please add the shipping fee to the total and provide return address:

- N-POST registered mail Ireland & Northern Ireland Zone 1 ( Next day delivery) - From €12
- Same day Dublin service D1 to D5 - From €15
- Same day Dublin service D5 to D10 - From €25
- Same day Dublin service D10 to D24 - From €35
- Prepaid self addressed mailer - €0
- Local pick up in Dublin - €0

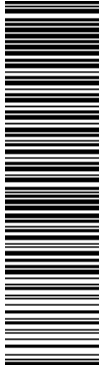

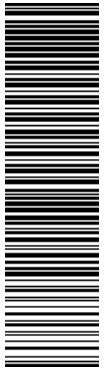
